#### **Rates of Use**

For non-edible crops: Per 100 L spray solution, use up to 2 L **Speedway Total**

For non-crop production, Per 100 L spray solution use up to 200 ml **Speedway Total**

For total spray volume, refer to the accompanying plant protection product instructions.

Always ensure thorough wetting of the target.

#### **Uses advised against:**

Do not use with fertilisers or trace elements.

#### **Mixing and Spraying**

Before use ensure that all spraying equipment is clean. Add half the required volume of water and start agitation, add the required quantity of Speedway Total. Add the plant protection product and fill the tank to the required volume whilst maintaining agitation. Continuous agitation must be maintained until spraying is complete. All application equipment must be thoroughly cleaned with water prior to storage or use on another crop.

- Green cover not being used for crop production
